

# ADMISSION FORM AGREEMENT

On behalf of myself, my spouse, and each child designated (my "Child"), I enter into this Admission Form Agreement ("Agreement") with Verrado Learn & Play regarding the provision of a supervised, learning and play environment for my child(ren),

**Facility Use:** Subject to this Agreement and other terms as drop-in, short-term childcare for my Child on a flexible time basis, which includes use of facilities and participation in learning, art and play activities. We do not take field trips or employ Community Resource Services.

**Future Visits:** This Agreement, the Registration Form and the Release (below) will be kept on file at Verrado Learn & Play where you originally registered. It will continue to constitute binding obligations for any future visits my Child may make to Verrado Learn & Play. However, this Agreement does not obligate Verrado Learn & Play to continue to provide services and Verrado Learn & Play reserves the right to refuse admission to any child for any reason without liability.

**Payment:** Payment for Verrado Learn & Play services will be due at the time of each check-out in cash, charge or debit card in the amount calculated by multiplying the time elapsed from check-in to check-out by the rates posted on the Registration Form. Verrado Learn & Play may charge a service fee for any unpaid invoices. No refunds are given. Any changes in fees will have a 30 day notice.

## **Health Policies:**

**a) Health:** My Child is in excellent health and physical condition and has no medical, psychological, physical or mental condition that has not been disclosed to Verrado Learn & Play on the Registration Form. My Child does not have any infectious, contagious or communicable diseases.

**b) Illness:** In the event my Child becomes sick with a contagious illness after visiting any Verrado Learn & Play location during the gestation period of such illness, I agree to notify Verrado Learn & Play as soon as possible to enable Verrado Learn and Play, in its discretion, to notify each family of all the children who may have been exposed.

## **Medical Procedures:**

**a) General Medical Guidelines/Discretion:** Although Verrado Learn & Play tries to provide a safe environment, it is possible my Child could get injured. In such event, I authorize Verrado Learn & Play to follow its internal procedures, including simple first-aid as reasonably appropriate; however, I understand Verrado Learn and Play shall not be required to strictly follow those guidelines when, in its judgment, circumstances may require otherwise.

**b) Medical Authorization:** In the event Verrado Learn & Play determines emergency medical attention is necessary for my Child, Verrado Learn & Play is authorized by me or whoever signs my Child in for that day, ("Authorized Individuals"), to act as an agent for me and to give my permission for my Child to be attended by a physician in such circumstances as Verrado Learn & Play deems necessary.

**Safety/Indemnity:** I agree that Verrado Learn & Play may take action which it considers prudent to protect the safety of my Child, and other children visiting Verrado Learn & Play. I further agree to indemnify, defend and hold Verrado Learn & Play (and its owners) harmless from and against all actions, claims, or liability, including attorney fees and court costs, directly or indirectly caused by my Child or resulting from any inaccuracy or omission made by me in completing the Registration Form.

**Additional Requirements:**

**a)** As a condition to my use of the services, I have accurately completed and signed the Registration Form and Release (below). I understand that Verrado Learn & Play will rely on this information in caring for my Child.

**b)** I agree to pay all cost and attorney fees arising out of any action relating to this Agreement, the Registration Form or the Release for collection purposes or otherwise.

## RELEASE

Verrado Learn & Play provides a fun and safe environment for children. However, in any childcare program, injuries may occur. In order for Verrado Learn & Play to be able to provide hourly childcare services to you, it is necessary that you assume certain risks. Thus, as a requirement to receive our services, Verrado Learn & Play is requesting that you sign this release.

On behalf of myself, my spouse and each child designated on the Admission Form Agreement (my "Child"), waive and release all rights, causes of action and claims against Verrado Learn & Play (and its owners) for any and all loss of or damage to property or injuries suffered by my Child during the time my Child is visiting, including the possible negligence of Verrado Learn & Play, but excluding gross negligence and intentional misconduct. I understand that the provision of child care contains risk of injury to persons and damage to property, and that by signing this release I engage Verrado Learn & Play to provide temporary child care for my Child at my own risk. I represent that I am authorized to sign this release on behalf of the child(ren) listed.

2. I have been given an opportunity to ask questions and obtain answers to my satisfaction regarding any and all aspects of Verrado Learn & Play and the Release, including, but not limited to, future risks, complications and costs. By signing this Release, I have not relied on any promises or statements made by Verrado Learn & Play other than those contained in the written information supplied to me by Verrado Learn & Play.

3. I understand that this Release will be kept on file at Verrado Learn & Play and will continue in effect for this and any future visits my Child may make to any Verrado Learn & Play.
